Our properties in the Dominican Republic surround the Pueblo Viejo and Falcondo Mines, and have the potential to contain large gold and nickel laterite deposits.

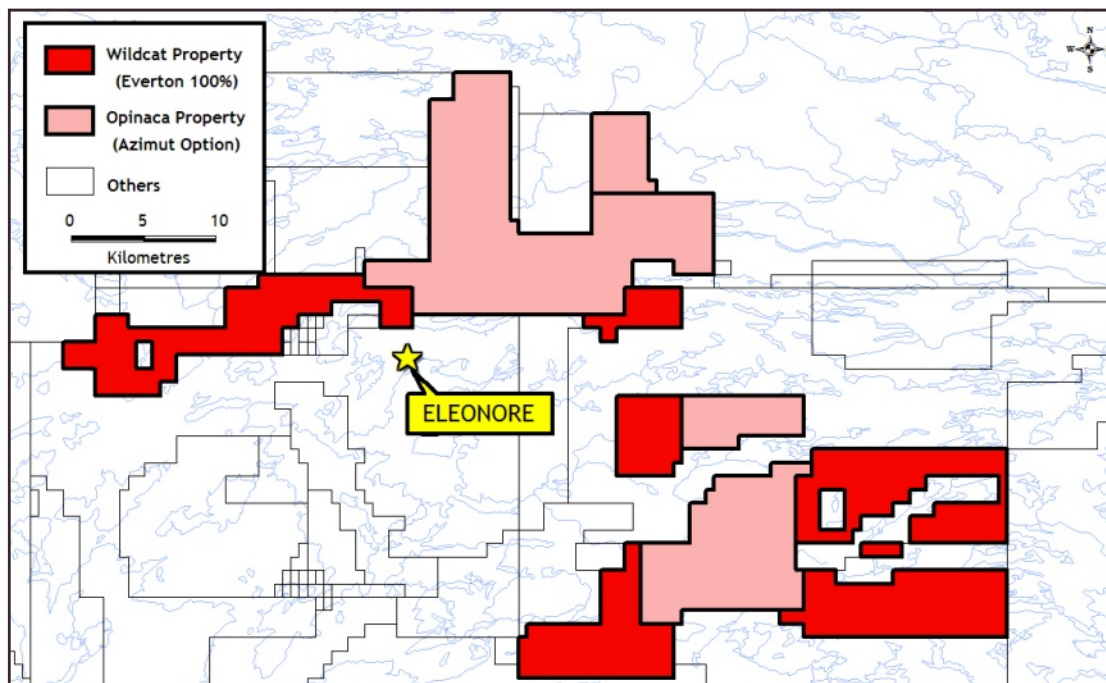
- Mapping, soil sampling, trenching and drilling on Loma El Mate concessions

## Eleonore Gold Discovery – Quebec



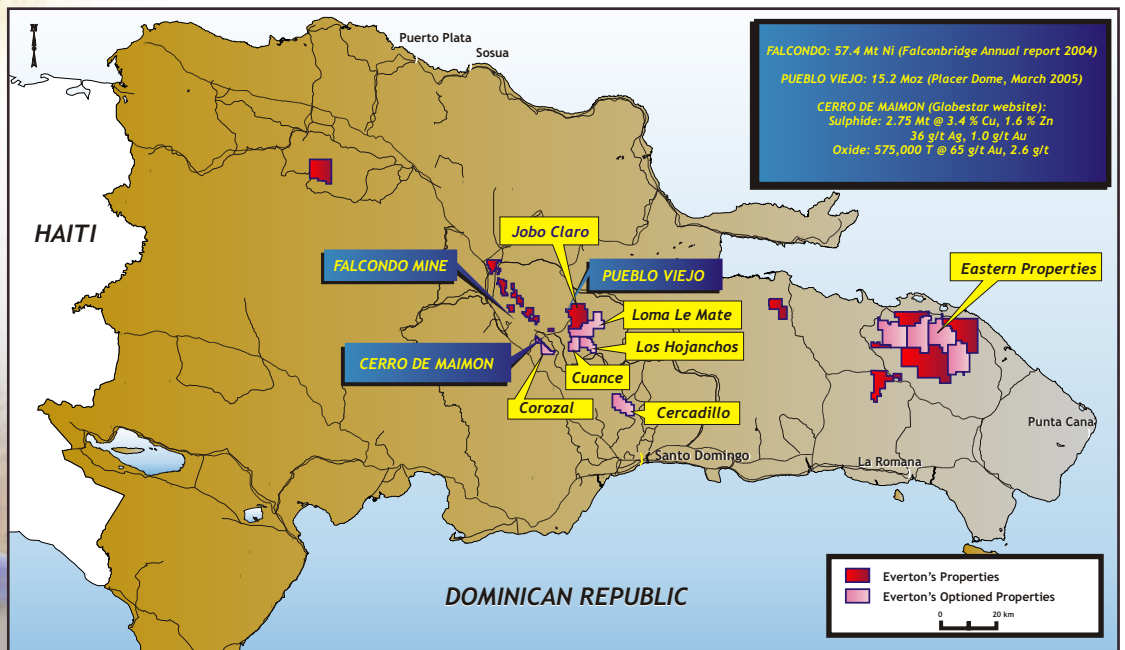
- Favourable tax regime and financial incentives to promote exploration
